1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned

Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

10. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**1. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised

quantity or duration

## 2. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

ASSISTANT DIRECTOR OF EDUCATION (TEXT BOOK)

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

## 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

**a.** The vendor/service provider shall transport the NCERT Text books in proper manner within 15 days as per buyer's requirement after award of the contract (including its packing in water proof carton/bags duly counted and stacked). The contractor would be responsible if the books were lost / damaged., torn school text books will not be accepted.

**b.** Rate quoted should be inclusive of all kinds of taxes, packaging, loading, unloading upto door delivery of the following destinations, all other charges and levies.

**c.** The estimated cost worked out based on the market survey average rate to different DDO's/Zone-wise and the vendor shall be responsible for arrangement of packaging materials and transportation and abide the conditions, no packaging materials will be provided from buyer.

**d. The vendor should make sure that the Textbooks being transported are insured through reputed Insurance Company and if there is any damage or the loss of the books the Contractor shall be liable for 100% compensation of Textbooks costing rupees shall pay at the time of any incident occurred. "In the event of any damage to or loss of books during transportation, the service provider shall be solely responsible, and the bidder must refund the full cost of the affected books.**

**e.** As per Rule-170, GFR2017, a bid security declaration to be submitted by the eligible bidders.

**f. Scope of Work:** Collection of NCERT Text Books from Office of the Assistant Director of Education (Text Book), Text Book

**Bureau, Middle Point, Sri Vijaya Puram** including packing, loading, unloading and deliver the same in standardized packages **to various DDOs under North and Middle Zone by road route ( Headquarters to different DDO's in North and Middle Zone ) in Andaman and Nicobar Islands** without any damage as per the bid.

g. Approximate quantity involved in the work: The actual quantity of school textbooks may vary depending on the weight of the textbooks and it may be higher or lower than the estimated quantity by 2.5%.

h. The unit cost will be worked out based on the total cost offered. Final payment will be made based on the actual weight of the school textbooks transported duly ascertained from port or other such authorities. The transporter will be required to submit copy of the weighing slips / packaging of the consignment issued by the port authorities.

i. The total number of standardized packages are approximately 306 boxes / packages [(Volume: 20.196 Cubic meter (CBM)/ 20196000 Cubic Centimeter of material to different destination as per above table and as per buyer's requirement/Vouchers).

j. The transporter concerned will be responsible for the safe delivery of school textbooks. The transporter will be responsible for the Loss /Damage to the school textbooks during the transit.

k. During the contract period, the vendor/supplier/transporter to transport the whole contracted quantity in full.
